Commissioner Reed thanked the Public for coming out.

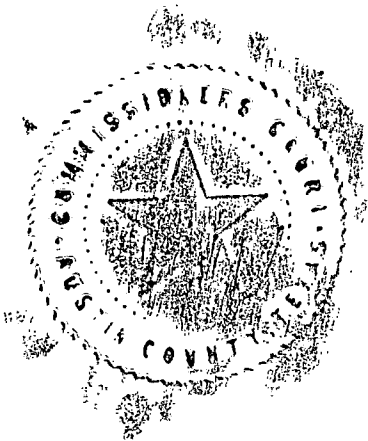
