A conviction of an offense under the* Texas Motor Safety-Responsibility Act* will result in the suspension of your driver's license and motor vehicle registration unless you provide and maintain proof of financial responsibility with the Department of Public Safety for two years from the date of conviction. Department may waive the requirements to file proof of financial responsibility if you file satisfactory evidence with the Department showing that at the time the citation was issued, the vehicle was covered by liability insurance or that you were otherwise exempt from the requirements to provide evidence of financial responsibility.

If you wish to enter a plea of “**GUILTY OR NO-CONTEST**”, please indicate below in the proper space provided. “**NO-CONTEST**” means that you do not contest the Charge against you and you will be found guilty. Either plea indicates that you agree and waive your rights to an appearance before the Court for trial by JURY.
