1. Workshop to review budget requests and action as appropriate.

Jail - Jailer Training Officer, overtime, misc. supplies/cleaning, and uniforms.

Sheriff - Including second Narcotics Officer, as last budget the officer was left off, 3% increase for all employees except Dispatch, 4% increase and 4 hours of overtime for Dispatcher Supervisor, and one part-time receptionist turn into full time position. There is a substantial increase in Repairs and Replacements.

Commissioner Turner requested the Sheriff trim up his budget.

Human Resources - Part-time pay increase to \$12.50/hour. Per Judge Lapham increase part-time hours from 29.75 to 30.

Treasurer - add another Deputy Treasurer.

Tax Collector - pay increase for Election Judges/Clerks and 3% increase for employees. Security at the Tax Office, but not included in budget paperwork.

EMS - 3% increase for employees, one full time EMT and replacement of Squad 10.

Capital Outlay - EMS, Patrol and Constable vehicles are needed.

Billy Doherty, County Auditor, inquired about bringing back Per Diem.

2. Consideration and possible action to adopt a proposed tax rate and if necessary schedule public hearings.

3. Consideration and possible action to change court date.

Move August 22nd to August 23rd. Add Court on August 29th.
