## E.M.S. Station Construction Workshop.

Report from Christensen Building Group, Austin Shaw

#### Schedules:

### Bellville:

- Still waiting on drainage report and new elevations for entire site. Supposed to have report by Friday. Per Billy Doherty (County Auditor), three months of delays for Bellville permit are unacceptable. Per Kenneth Burns (Burns Architecture), hold up is on civil engineer. Supposed to have updated drainage report, not permit, this Friday. Per Commissioner Lamp, need to have a schedule for each building laid out before next update meeting.
- Cost of site work is \$107,870.00. Per Commissioner Lamp, on last two jobs county provided trucks to haul dirt, need to ensure that county receives credit for hauling. County can provide trucks for Bellville and Industry sites; cost of hauling should be removed from quote.

#### Wallis:

- Main steel structure is complete.
- Roof should be complete by end of week.
- Structure framing and waterproofing should begin by end of week.
- Paving should begin in the next two weeks.
- Per Kenneth Burns (Burns Architecture), after site visit, insulation is installed correctly, just different than other buildings due to changes in energy code.

#### Industry:

- Slab scheduled to pour tomorrow then rough grade paving area by end of week.
- Utilities to start next week.
- · Building erection to start within next two weeks.
- Per Commissioner Lamp, water meter box that feeds 911 office will now be in the middle of driveway and needs to be relocated.
- Paving apron along one side needs to be extended at site to provide enough turning area for emergency equipment.

#### Fire alarms:

• Look into running alarms through the sheriff's department for E.M.S. stations to save on third-party monitoring fees.

Update on Justice Center issues:

- Per Kenneth Burns (Burns Architecture), quote of \$12,865.00 from R.E.C. Industries
  to correct various water issues at Justice Center; does not fall under warranty
  because they did what they were supposed to do during construction, correcting the
  water issues would be changes to that. Per Commissioner Reed, having a real
  struggle paying \$12,000.00 more to fix something he believes was designed wrong
  and did not work on either building. Per Commissioner Lamp, original jail had no
  water issues before construction of new building addition and Justice Center. Per
  Kenneth Burns (Burns Architecture), some issues could be because of recent code
  changes.
- Commissioner Reed questioned completion/correction of roof leak issues. Per Ronnie Thrasher (Maintenance Coordinator), still have leaks in both court rooms and adult probation, insulation in leaking areas will need to be pulled out and replaced. Per Kenneth Burns (Burns Architecture), not positive if anyone had shown up to look at issues; he will look into current status.
- Commissioner Reed questioned floor tile issues related to county seal on floor at main entrance. Burns Architecture does not know current location of the boxes of extra floor tiles, but will try to locate them.
- Per Kenneth Burns (Burns Architecture), need to look into issues with the matting in the detention pond and how to control erosion issues. Per Commissioner Lamp, matting should not have been installed when it was; dirt work was not ready. Erosion is too bad now to mow and maintain pond slopes.
- Per Commissioner Reed, it is completely unacceptable that project manager (Burns Architecture) is being paid to oversee the projects, but does not know what to do to solve issues and asks the commissioners what they want him to do. The architect needs to be on site given how many problems there have been with the Justice Center and the new E.M.S. stations. Per Kenneth Burns (Burns Architecture), he will have Eddy Morgan and R.E.C. at next meeting along with dirt contractor, roofer, plumber and civil engineer on May 30 at 9:00 a.m.
