Motion to Adopt: Commissioner Reed, 2nd Commissioner Rinn, passed (4-0). **Order #23-773**

Sergeant Donald Darracq spoke in regards to TXDOT IBM Grant.

3. Discussion and action to approve payment of JPATS/USMS Invoice 12293 for transport services of a prisoner.

Per Travis Koehn (District Attorney), decision to extradite a person is reviewed and determined on a case-by-case basis. Requests that County pay invoice for this extradition.

Per Sheriff Jack Brandes, once an order is received from the magistrate, required to retrieve fugitive. Most cases the U.S. Marshal is used.

Per Billy Doherty (County Auditor), refuse to pay invoice. The \$7,336 invoice is past due and it falls under the previous fiscal year. There is not a current budget line item or monies set

aside to make the payment. Billy requests District Attorney and Sheriff's Office split the bill and pay from their forfeiture funds.

Per Commissioner Reed, recommends creating a line item in the budget to use for extradition expenses only and Billy Doherty (County Auditor) agreed.

4. Discussion regarding contract with US Marshall's Service to transport a subject to Austin County and action as appropriate.

Sergeant Donald Darracq (Sheriff's Office) requests approval for payment of \$2,670.00 to U.S. Marshal to extradite a felon to Austin County. Billy Doherty (County Auditor) agreed to approve payment based on quote amount and prior notice given.

Per Sergeant Donald Darracq (Sheriff's Office), new proposal has been quoted at \$1,400.00 and requests to work with the auditor's office to do a grant adjustment.

Per Billy Doherty (County Auditor), money will be returned through E-Grant. Will assist Sargeant Darracq with grant adjustment.

Per Judge Lapham, Emergency Management needs an administrative assistant to relieve some of the clerical duties from Roy Mercer (Emergency Management Coordinator).

Approve hiring 2 part-time positions not to exceed \$18.00 per hour for 24 hours per week to the compensation order; one for County Engineer and one for Emergency Management Coordinator.
