# 4. Presentation by Perdue, Brandon, Fielder, Collins & Mott regarding property tax/fine/fee collections

Mike Darlow presented updated graph reports of fines and fees.

# 5. Request to pay vacation Law Enforcement employees totaling \$37,380.18 and action as appropriate

Sheriff Burger and Jerry Green, Jail Captain, requested paid vacation for deputies and jailers be the same as EMS employees. Their concern is fairness among all departments.

Per Debra Mergel, Legal Counsel, "The policy is what the policy is", if you want to change the policy you can, but it can't act retroactively. The employee in EMS was a one-time deal.

Per Judge Bilski and Commissioner Reichardt, vacation should be zeroed out if not used by employee's anniversary dates.

Chief Richard Holloman noted it was not one person in EMS, there were several people who were paid.

Per Judge Bilski, everybody can take a day off here and there; you don't have to take it all at one time. If budgeted for a full staff and the department is under staffed, extra money should be in the budget.

Per Sheriff Burger, there are paid part-time employees who show up when someone is sick. He cannot mandate usage of vacation time when they are under staffed.

Commissioner Reichardt asked if there were any suggestions other than paying over-time. We can't raise the salary just to compete with other counties

Per Captain Green, they have very few full-time employees to fill shifts 24/7. He questioned why this situation was excused for EMS and not their department? He added that SCAAP Funding (State Criminal Alien Assistance Program) will help while staffing is low.

Per Commissioner Reichardt, EMS was a one-time payment of \$5,000.00. We don't have a solution; something needs to be figured out through your budget.

Per Commissioner Ottmer, need to study options so nothing is done illegally, and we regret it later.

Sheriff Burger requested that if nothing is done today, keep this in mind for July. Don't punish employees that want to work and do their jobs. Paying comp-time would be a big help, or give them an extension as to not lose vacation time.

Commissioner Reichardt does not think it is in the policy, may have to be built in the budget.

Lt. Al Cordeiro suggested the court re-exam the 171 Rule under the FLSA and change to the 160 Rule for over-time.
